AGGREGATE VERIFICATION

Your application for financial aid was selected for review in a process called "Verification". No funds will be disbursed until the verification process is completed. Failure to complete the verification process by the deadline will result in your ineligibility for Title IV funds for the award year. If there are differences between the information supplied on your federal application and your financial documents, we will need to correct this information. We must review the required information under the financial aid program rules (34 CFR, Part 668).
