**MUST CONTAIN VEHICLE PLATE NUMBER TO PROCESS**

**Parking privileges and sticker:** have been issued to you for *your* use **ONLY**. Please do not loan, share or transfer **YOUR PARKING DECAL** to anyone. Submitting false information to gain additional stickers will result in loss of parking privileges. The operation of your motor vehicle on campus is a privilege granted by University administration and is revocable at any time. The University assumes no responsibility for damage to any vehicle while it is being operated or parked on University property.

**Parking Rules and Regulations:** All moving and stationary vehicle laws, ordinances, rules and regulations of the state of Arizona, city of Phoenix, and Grand Canyon University together with adopted amendments will be enforced 24 hours a day. Traffic laws are no different on or off campus; but due to the higher concentration of pedestrians, the speed limit is **15 mph**. Please exercise a conscious effort to watch your speed and drive defensively.

Please park only in **Designated** Parking Areas and striped parking spaces.

**Do no park in, in front of, or block...**

- Campus streets
- Pedestrian walkways
- Loading zones
- Barricades
- Grass or gravel areas
- Handicap Parking Spaces

All motor vehicles on University property must display a current GCU parking decal. It is to be displayed on the lower corner of the front windshield, driver's side.

**TICKET FINES:**

All fines can be paid at the Business Office. Appeal of any ticket must be made within (7) seven days of issue in the Campus Public Safety office.

**VISITOR PARKING:** Visitors are encouraged to obtain a temporary parking pass at the Public Safety office. Visitor parking is available at the front of campus.

**Damaged or worn parking decals:** Replacement is free when it is determined that the sticker was not damaged deliberately or due to negligence. Stickers can be removed by Facilities Management, the Office of Public Safety, or Human Resources upon expiration or departure from service with Grand Canyon University.

**Violations:** - *Any misuse or violation* of this agreement will result in *any or all* of the following: citations being issued, loss of parking privileges at Grand Canyon University for at least 30 days, or your vehicle being booted or towed at owner's expense. Suspension of your parking privilege will commence on violation date. An appeal may be made for reinstatement within three (3) working days through the Director of Public Safety.

**Vehicle Registration:** All vehicles must be registered in the State of Arizona (exception: vehicles registered to Active Duty Military and "out of state" students attending the university) to qualify for parking privileges pursuant to Arizona Revised Statutes.

Proof of insurance is also required.

Grand Canyon University assumes no liability for vehicles parked on campus property.
